Medicare Telehealth Flexibilities Update

The Academy is holding listening sessions to inform members about updates to the Medicare Physician Fee Schedule, per the [final rule released by CMS](#) in December, and how they impact our practice. Among other implications, Medicare telehealth flexibilities have been extended through March 31, 2025.

To support their continued advocacy efforts and to include in comments to CMS, the Academy seeks case example of healthcare institutions that are limiting or stopping provision of MNT via telehealth for reasons other than changing Medicare Part B flexibilities in 2025.
