Free Article: "Vegetarianism, Traditional Practices, and Belief Systems in India"

Curious about the over 2000-year-old practice of vegetarianism in India? Then I am excited to share a new paper <u>"Vegetarianism, Traditional Practices, and</u> <u>Belief Systems in India"</u> by DCMAND Board Member Leila Saldanha, PhD, RD, FAND and Sheela Krishnaswamy in Nutrition Today. The paper describes traditional practices like the classification of foods in #Ayurveda, the thali eating system, and fasting which can be #personalized to meet your individual eating needs and preferences. Over 500 million or 39% of all Indians are vegetarians, which varies by religion (8 to 92%) and region (9 to 90%). The article is free from the Nutrition Today website until July 26, 2024.

DC Medical Care Advisory Committee

Each State Medicaid program is required by Federal Regulations to have a Medical Care Advisory Committee (MCAC) which includes provider, consumer, and government representatives and which participates in policy development and program administration.

The DC MCAC advises the DC Department of Health Care Finance (DHCF) which administers DC Medicaid. The DC MCAC currently has five vacancies on its MCAC, two of which are for "advocacy seats". Applications are due by July 19th. For more information, visit the <u>DHCF MCAC web page</u>.
